MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MoU) is made and executed on

BY AND BETWEEN

SPSVS's Shivsamarth Institute of Management, Talmavale, having its registered office at 211, Matoshri Krupa, Talmavale, Tal-Patan, Dist. Satara – 415103, Maharashtra, India (hereinafter referred to as "SIM")

AND

Shivsamarth Nagari Sahakari Patsanstha Ltd., Talmavale, having its office at Talmavale, Tal-Patan, Dist. Satara, Maharashtra, India (hereinafter referred to as "Patsanstha")

SIM and Patsanstha are hereinafter collectively referred to as "Parties" and individually as "Party".

Purpose:

The purpose of this MoU is to establish collaboration between SIM and Patsanstha for academic development, financial literacy, skill enhancement, and community engagement.

Objectives:

The key objectives of this MoU are:

- To promote financial literacy among students
- To provide practical exposure to cooperative banking operations
- To facilitate internships and training opportunities
- To promote entrepreneurship and self-employment awareness
- To strengthen industry-academia collaboration

Areas of collaboration:

The collaboration may include:

- Internship opportunities for students
- Training programs in cooperative banking and financial services
- Financial literacy and awareness programs
- Guest lectures by Patsanstha officials
- Student projects related to banking and finance
- Placement support and career guidance



Expectations from the Parties

Responsibilities of Patsanstha

Patsanstha agrees to:

- Provide internship and training opportunities to students
- Offer practical exposure to cooperative banking operations
- Conduct guest lectures, workshops, and awareness programs
- Share expertise in financial and banking practices
- Support placement activities wherever possible

Responsibilities of SIM

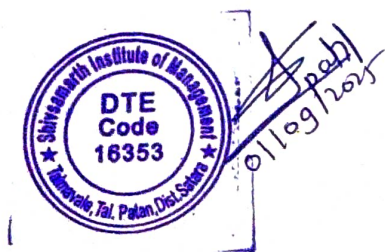
SIM agrees to:

- Nominate eligible students for internships and programs
- Provide necessary infrastructure and academic coordination
- Organize and facilitate joint activities
- Maintain proper documentation and reports
- Ensure discipline and active participation of students
- understanding between the parties
- Any amendments must be in writing and signed by both parties
- Any disputes shall be resolved amicably

Execution and Operational Review :

- SIM and Patsanstha will review the operations of the program yearly. The purpose of the review shall be to assess the planning and operations of the program including, but not limited to its quality, timeline, performance and progress. The subject of expansion and amplification of the scope of this MoU will also be discussed during the review meeting.

General Provisions :



- 1) The parties shall discuss and finalize the detailed scope of work to be performed by each party for each assignment and agree on all considerations for the same.
- 2) Except as agreed above neither party shall make a claim against the other party for any expenditure unless such expenditure has been agreed upon in writing between the parties.
- 3) The implementation of the areas and forms of cooperation identified in this MoU shall be subject to the availability and convenience of faculty, research-scholars, students and infrastructure facilities at the parties' work place.

Relationship of the Parties :

This MoU is not intended to create a relationship such as a partnership, joint venture, or agency. Neither party may act in a manner that expresses or implies a relationship other than independent contractor, nor bind the other party. Participation in this MoU shall not prevent either party from entering into similar MoUs with other institutions.

Validity :

Unless extended by the Parties in writing this MoU shall remain valid and effective for a period of Three (03) years from the date of execution, hereof, and can be extended for a further period of Two (02) years. Either Party may terminate this MoU by sending a prior written notice of not less than one (01) month.




Miscellaneous :
